# Humber Station Road Community Expansion Project Notice of Upcoming Study Enbridge Gas Inc.

## Project Overview

This notice is to inform you of an upcoming study to support the Enbridge Gas Inc. (Enbridge Gas) Community Expansion project in the Town of Caledon, Region of Peel. The purpose of the project is to provide residents, businesses and industries located in the Town of Caledon with access to safe, reliable and affordable natural gas services.

# Upcoming Study

Enbridge Gas has retained Dillon Consulting Limited (Dillon) to undertake a pipeline route selection study, Stage 1 Archaeological Assessment, cultural heritage screening, and an environmental assessment and report for the project. The study is being conducted in accordance with the Ontario Energy Board (OEB) *Environmental Guidelines for the Location, Construction, and Operation of Hydrocarbon Projects and Facilities in Ontario, 8th Edition* (2023).The study will review the need and justification for the project; describe the existing environment (built, natural, socio-economic, and cultural); identify and assess potential adverse environmental impacts including cumulative effects; describe reasonable measures to avoid, minimize, and mitigate adverse impacts; evaluate the potential routes; and, select the preferred route.

Once the study is complete, Enbridge Gas plans to file a Leave-to-Construct Exemption with the OEB in 2025. Pending receipt of all approvals, construction is anticipated to begin in 2027, with an anticipated in-service date in 2027.


